Health Insurance: Include proof of comprehensive health insurance coverage for your entire stay in Turkey.







Passport Photos: Provide recent passportsized photographs that meet Turkish visa photo specifications.

Visa Fee: Pay the non-refundable visa application fee, as determined by Turkish authorities. The current visa fee for a student visa for Turkey is €60

Language Proficiency Requirements

- •IELTS- A minimum band score of 6
- TOFEL iBT- A minimum score of 80
- PTE Academic- A minimum score of 58

APPLICATION PROCEDURE

What is a student visa for Turkey?

A student visa for Turkey is an extended-stay visa that permits foreign individuals to enter and reside in Turkey to pursue studies at a recognised educational institution. The visa remains valid for the duration of the study programme, with an additional grace period of 90 days.
